## Summary

The 2022-2024 Diocesan Executive adopted the 2024 Toronto Diocesan Manual of Policy & Procedure at the March 23, 2024, Executive Meeting. The manual is effective May 1, 2024, for use during the 2024-2026 Executive term. The manual supersedes the 2022 and all previous manuals. The updates reflected changes in the reduced League executive structure from 12 to eight officers.

Changes also includes events and practices within the Toronto Diocese such as the Moira Ste. Marie Lecture Series, Patricia Beattie Award, Indigenous Mass, Ordinandi and Spiritual Bouquet, brief TDC council history, storage locker, land acknowledgement, newsletter editor duties, website host and administrator duties, convention chair and co-chairs, liability insurance, annual report process, etc.
